

# JEROME'S LABOR DAY \$5,000 SHOPPING SPREE OFFICIAL RULES

## THE SPONSOR:

Entry Period #1 begins: Saturday, August 27, 2022, at 10:00 am PST and ends on Sunday, August 28, 2022, at 11:59 pm PST.

Entry Period #2 begins: Friday, September 2, 2022, at 10:00 am PST and ends on Monday, September 5, 2022, at 11:59 pm PST.

Entry Period #3 begins: Saturday, September 10, 2022, at 10:00 am PST and ends on Sunday, September 11, 2022, at 11:59 pm PST.

### **\$5,000 GRAND PRIZE DRAWING:**

Entry Period #1, a total of one (1) Entrant will be selected in a random drawing Wednesday, August 31, 2022, at 3:00 pm PST. The "Selected Entrant" must meet the conditions outlined below in order to be declared the "Winner." Odds of winning depend on the number of eligible entries received.

Entry Period #2, a total of one (1) Entrant will be selected in a random drawing Thursday, September 8, 2022, at 3:00 pm PST. The "Selected Entrant" must meet the conditions outlined below to be declared the "Winner." Odds of winning depend on the number of eligible entries received.

Entry Period #3, a total of one (1) Entrant will be selected in a random drawing Wednesday, September 14, 2022, at 3:00 pm PST. The "Selected Entrant" must meet the conditions outlined below in order to be declared the "Winner." Odds of winning depend on the number of eligible entries received.

### **PRIZE DETAILS:**

A total of one (1) Grand Prize will be awarded per Entry Period for a total of 3 Grand Prize Winners. The Grand Prize is \$5,000 Jerome's Gift Voucher valued at \$5,000USD each.
